by the Information Commissioner in 2008

INTRODUCTION

1. Legal requirement

- 1.1 Adopting a publication scheme is a requirement of the Freedom of Information Act 2000. This Act promotes greater openness and accountability across the public sector by requiring all 'public authorities' to make information available proactively, through a publication scheme.
- 1.2 'Public authorities' are defined in the Act and include universities and the act also applies to companies wholly owned by at least two public authorities. The act therefore applies to Graphene Enabled Systems Limited.

2. The Publication Scheme

- 2.1 A publication scheme is a document which describes the information a public authority publishes, or intends to publish. In this context, 'publish' means to make information available, routinely. These descriptions are called 'classes of information'. The scheme is not a list of the actual publications, because this will change as new material is published or existing material revised. It is, however, the public authority's commitment to make available the information described.
- 2.2 A publication scheme must set out the classes, or categories, of information published. It must also make clear how the information described can be accessed and whether or not charges will be made.

3. Who we are

- 3.1 The University of Manchester is recognised as one of the global leaders in academic research with 65% of research activity judged to be "world leading" or "internationally excellent" (2008 Research Assessment Exercise). This prolific research activity forms part of the largest academic campus in Europe and produces world-leading breakthroughs.
- 3.2 Graphene Enabled Systems is a business created and owned by The University of Manchester.

Our objective is to launch a series of successful, market-focused 'spin-out' businesses based on products born out of the University's portfolio of 2D materials technology patents – principally graphene.

4. Accessing information covered by the publication scheme

- 4.1 The classes of information we publish are described in the second part of the scheme.
- 4.2 Next to each class we have indicated the manner in which the information described will be available. There will be no charge for information covered by the publication scheme.

- 5.2 Requests will have to be made in writing and the Company will normally have 20 working days to respond. We may charge a fee. We will not be required to release information to which an exemption in the Act legitimately applies.
